# APLICATION REQUIREMENTS FOR DUPLICATE REGISTRATION BOOK / DRIVER LICENCES/ VEHICLE LICENCE.

#### 1) DUPLICATE REGISTRATION BOOK

#### Replacement of filled up / defaced /Lost Logbook

- 1. Original Logbook
- 2. Application form XI
- 3. Copy of ID/ Certificate of incorporation /Business Registration Certificate
- 4. A fee of Kshs. 500/- for filled-up, Kshs. 2,500/= defaced or lost Logbook
- 5. A police abstract and official / receipt for same must be attached (for lost cases)

#### Change of Color

- Original Logbook
- 2. Application form XI
- 3. Copy of ID/ Certificate of incorporation /Business Registration Certificate
- Application fee of Kshs. 800/- being Kshs 500/= for duplicate Logbook, Kshs.300/= for change of color

#### Change of Body and Class

- 1. Original Logbook
- Vehicle inspection report
- 3. Application form XI
- 4. Copy of ID/ Certificate of incorporation /Business Registration Certificate
- Application fee of Kshs. 1100/- being or Kshs. 500/= for duplicate logbook, Kshs 300/= for class and Kshs 300/= for body.

- Payable fees of Kshs. 875/=

#### **Defaced Driving Licence**

- Application form XI
- 2. The Defaced Licence
- 3. Two Passport size Photographs of the applicant
- 4. Photocopy of the ID
- 5. Payable fees of Kshs. 875/= if the licence has less than 3 months expiry period or Kshs 375/= if the expiry period has more than three months.

#### **Provisional Driver's Licence**

Another Provisional driver's licence is purchased for Kshs. 500

#### Note:

It is important to indicate on this form the licence number, year the first licence was issued and correct Order of names used

Where the reference of the licence is known, one should wait at the counter for 1 hour awaiting approval of the application to enable payment

However a delay of 2 days is unavoidable where the applicant does not know the reference

- Obtain Advance tax receipt from Income Tax Office
